

## **\*\*Mobishare Corporation Gift Card Terms and Conditions\*\***

Welcome to Mobishare Corporation ("Mobishare," "we," "us," or "our"). These Terms and Conditions ("Terms") govern the purchase and use of gift cards ("Gift Cards") sold by Mobishare through its website, [www.mobishare.org](http://www.mobishare.org) ("Website"). By purchasing or using a Gift Card from Mobishare, you ("you" or "the Customer") agree to be bound by these Terms. Please read these Terms carefully before purchasing or using a Gift Card.

### **\*\*1. Gift Card Redemption\*\***

**1.1 \*\*Eligibility:\*\*** Mobishare Gift Cards can be redeemed solely within the territory of Kenya through the mobile payment platform M-Pesa. To redeem a Gift Card, you must have access to M-Pesa and comply with M-Pesa's terms and conditions.

**1.2 \*\*Limitations:\*\*** Gift Cards are non-transferable, and their use is limited to the amount loaded onto the card. They cannot be redeemed for cash or used to purchase other Gift Cards.

### **\*\*2. Purchasing Gift Cards\*\***

**2.1 \*\*Purchase:\*\*** You can purchase Mobishare Gift Cards through our Website by selecting the desired denomination and completing the payment process. Payment methods may vary and are subject to change at our discretion.

**2.2 \*\*Validity:\*\*** Gift Cards are valid from the date of purchase until the date specified on the Gift Card, if applicable.

**2.3 \*\*Non-refundable:\*\*** All Mobishare Gift Card purchases are final and non-refundable. We will not provide refunds or exchanges for Gift Cards under any circumstances.
